## Work-in-progress

Monograph Manuscript: "A Secret History of the Sable Venus: Digital Literary Analysis and Early Black Atlantic Voices in Colonial Archives. The manuscript argues for a reorientation within literary digital analysis of early Black Atlantic archival voices and advocates for moving beyond questions of recovery in order to highlight the significant contemporary discursive and aesthetic investments of Black voices. Grounded in an exploration of the shifting representations of Black Caribbean Women in the print culture across the Long-18<sup>th</sup>-century (1709-1837), this study illuminates the intriguing connections between representations of Black Caribbean and contemporary White European sentimental heroines and models of femininity in texts produced before the appearance of Thackeray's Vanity Fair (1844) and the rise of the Victorian domestic novel--after which Black women effectively disappear as sentimental heroines in British and European literature
