Summary Bio

I am a Canadian citizen and U.S. permanent resident. I have a Ph.D. in criminology from Cambridge University. Currently, I am the Visiting Professor of Global Health and Social Medicine at Harvard Medical School, a Professor of Criminology at Northeastern University, and Co-Director of Northeastern University's Crime Prevention Lab. I am also the Director of the Cambridge-Somerville Youth Study (CSYS), a randomized controlled trial of a delinquency prevention intervention—with an embedded prospective longitudinal survey—of 506 underprivileged boys from Cambridge and Somerville, Mass., which was founded by Dr. Richard Cabot at Harvard University in 1935.

My research and teaching focuses on the prevention of delinquency, crime, and interpersonal violence (with an emphasis on developmental, environmental, and community approaches), developmental origins of offending, and evidence-based social policy. A major part of my research agenda is the CSYS, which is also the focus of my work at Harvard Medical School. I lead a multi-generational research team tracing participants into old age—and over the full life-course—to investigate intervention effects on offending and mortality, as well as criminal careers, desistance, and other developmental processes. I conduct historical research on the social and intellectual contexts related to the study, and work is planned to investigate intergenerational effects and transmission of offending (over three generations). Findings have been published in numerous journals, including *Journal of the American Medical Association Network Open, Journal of the Royal Society of Medicine, Journal of Experimental Criminology, Journal of Developmental and Life-Course Criminology, Journal of Quantitative Criminology, British Journal of Criminology*, and *Annual Review of Criminology*, and two books are under contract with Oxford University Press.

The other part of my research agenda involves primary and secondary research on crime prevention for social impact and social justice. This is a longstanding project with multiple foci, including investigating the need for striking a greater balance between prevention and punishment, interrogating experimental and quasi-experimental evaluation design methods, and assessing the processes and challenges of scaling up evidence-based interventions. Major works have appeared in such journals as *Criminology & Public Policy, Justice Quarterly, Prevention Science, Journal of Research in Crime and Delinquency, Crime and Justice, The Annals, Journal of Experimental Criminology, Journal of Quantitative Criminology, Punishment & Society, and Social Science & Medicine, and I am the author or editor of ten books in these areas. Some of this work has been featured in major national and regional newspapers, including New York Times, Wall Street Journal, Minneapolis Star Tribune, Times-Picayune, Ottawa Citizen, and Calgary Herald, as well as on Freakonomics Radio and Baltimore Public Radio.*
